1. A signed contract confirms your commitment. No Refunds.
2. Set up time starts at 6:00am until 9:00am on the day of the market. All Dealers must be set up prior to 9:00am and remain fully set up until 4:00pm. After 9:00am, no vehicles will be allowed to enter or leave the market until 4:00pm.
3. Dealers agree to accept the space and location assigned to them. Dealers may not change spaces/locations unless authorized by a committee member prior to the day of the event.
4. No dealer may assign its contract for Vendor space or permit any other person to use their space without prior permission by a committee member.
5. The Market will take place rain or shine.
6. St. Joseph reserves the right to limit the number of spaces to any one vendor. St. Joseph also reserves the right to limit the number of dealers in any one category.
7. Dealers will be responsible for providing all displays desired. All spaces are on a paved surface. Rental tables are available for a \$15 fee and Tents are available for a \$25 fee. All fees must be paid in advance.
8. Dealers must remove all their property and refuse prior to 6:00pm on the day of the event.
9. The undersigned Dealer completely and unconditionally released, discharges and waives any and all claims, damages, causes of action, and any other obligations of whatever nature or source, statutory or otherwise, whether known or unknown which Dealer may have against St. Joseph Parish, St. Joseph School, St. Joseph Parish School Organization or any of their present or former officers, directors, employees, members, agents, representatives, predecessors, successors, affiliates ("Released Parties"). Dealer acknowledges that this is a general release as to all the released persons and entities and their affiliates in connection with or in any way related to the **St. Joseph Parish School Organization's Oktoberfest Market and Family Festival**.
